

## 1. SPONSOR

The March Add-2-Win Challenge (“Contest”) is sponsored by LaneTalk AB (“Sponsor”). This Contest is not sponsored, endorsed, administered by, or associated with BowlersMart or any other third party.

## 2. CONTEST PERIOD

The Contest begins at 12:01 AM (EST) on March 1, 2025, and ends at 11:59 PM (EST) on March 31, 2025 (“Contest Period”). All entries must be received before the end of the Contest Period to be eligible.

## 3. ELIGIBILITY

- The Contest is open to legal residents of the United States who are at least 18 years old at the start of the Contest. The Contest is void where prohibited by law.
- If a winner is under the age of 18, a parent or legal guardian must approve prize acceptance.

## 4. PARTICIPATING CENTERS

The March Add-2-Win Contest will be held at the following participating centers. Each center will have its own 11 winners.

Participants qualify by:

- Bowling at a participating center during the Contest Period (March 1–31, 2025).
- Adding their games in the LaneTalk app no later than March 31, 2025.
- Each game added in the app counts as one (1) entry toward the prize selection.

Important:

- Games must have been played in March, but participants can add them at any time during the Contest Period (even if they were played earlier in the month).
- No additional purchase necessary. Participants do not need to bowl specifically for this contest – they can add games they have already played at a participating center.
- The contest is open to all LaneTalk users. A paid subscription does not increase the chance to win.

## 6. REWARDS & WINNER SELECTION

A total of 11 participants per center will be selected as winners. Grand Reward (1 winner per center):

- A \$300 BowlersMart gift card that can be used to purchase a bowling ball.

Runner-up Rewards (10 winners per center):
