

1. SPONSOR

2. CONTEST PERIOD

3. ELIGIBILITY

- The Contest is open to legal residents of the United States who are at least 18 years old at the start of the Contest. The Contest is void where prohibited by law.
- If a winner is under the age of 18, a parent or legal guardian must approve prize acceptance.

4. PARTICIPATING CENTERS

- Each game added in the app counts as one (1) entry toward the prize selection.

Important:

- Games must have been played in April, but participants can add them at any time during the Contest Period (even if they were played earlier in the month).
- No additional purchase necessary. Participants do not need to bowl specifically for this contest – they can add games they have already played at a participating center.
- The contest is open to all LaneTalk users. A paid subscription does not increase the chance to win.

6. REWARDS & WINNER SELECTION

A total of 11 participants per center will be selected as winners. Grand Reward (1 winner per center):
